- Copy of last year's federal & state returns if available
- Valid photo ID
- Documentation for ALL income from work, Social Security or pensions, including forms W-2, 1099's
- Education expenses & student loan payments
- Total amounts paid for child care. Bring day care providers address and tax ID number
- Bank routing and account number for direct deposit of any refund.
- Copy of mortgage 1098 statement and receipt for paid property taxes.
- Access CT forms, 1095A
- Copy of Health Insurance forms 1095B or C
