

Frequently asked Questions regarding ACTIVE WARRANTS

1. *How do I know if there is a warrant for me?*

You can come to the Police Department (1 Union Avenue, New Haven, Ct) with positive identification and see the front desk sergeant on duty.

2. *What do I need for positive Identification?*

Any government photo identification (driver's license, passport, etc.) or working photo identification.

3. *What if I do not have any photo identification?*

You can still come to the front desk of the Police Department and the front desk sergeant will check for you.

4. *What time is do I turn myself in if I have an active warrant?*

- Anytime. (Police Department is open 24 hours a day)
- If you turn yourself in between the hours of **4:00am** and **6:00am**, **Monday-Friday**, you will be able to go before a judge at court.

5. *How long is the process after I turn myself in?*

It depends on the number of people that are in detention at the time.
Best time for processing and same day court visit is to come early in the morning.

6. *If I have a Bond set for my charges, what happens?*

After you are processed your bond is reviewed by the Bail Commissioner who will give you a PTA (Promise To Appear)

or

If a Court Set Bond, you pay 10% of the bond (Example- if bond is \$10,000, you have to pay \$1000)

7. *What happens if I do not have the money to pay the bond?*

If you turn yourself in to the **New Haven Police Department (1 Union Avenue) at 4:00am-6:00am, Tuesday – Friday**, you can be processed and go to court the same day and your case can be heard by a judge.
