Removal or Demolition of any Building or Structure

For buildings or structures not exceeding 5,000 cubic feet	\$ 75.00
For buildings or structures exceeding 5,000 cubic feet but not exceeding 50,000 cubic feet	\$150.00
For buildings or structures exceeding 50,000 cubic feet plus for each additional 5,000 cubic feet	\$ 40.00
For any building ordered demolished by governmental authority (except in a building under 5,000 cubic feet)	\$150.00
Inspection Fee	\$ 28.00
Legal occupancy analysis	\$ 40.00
